Thank you for your request received on 18 February 2021, for the following information:

NHS DIgital report that in 2019/10 Barnet's total gross current expenditure was £120,518K, gross current expenditure on long term care for people aged 18-64 was £55,004K and £47,237K on long term care for people aged 65+.

Could you please provide me with the budget planned at the beginning of the financial year for each of these three expenditures.

We have processed this request under the Freedom of Information Act 2000.

Response

I can confirm that London Borough of Barnet holds the information you requested.

However, we believe that the exemptions detailed below apply to some/all the information you requested and so we are withholding that information. Please see the Refusal Notice below.

Could you please provide me with the budget planned at the beginning of the financial year for each of these three expenditures.

We consider that the absolute exemption set out in Section 21 (Information accessible by other means) applies to the information requested because the information requested is already reasonably accessible elsewhere.

DELETE BLUE TEXT BEFORE SENDING RESPONSE OUT/TO IMT TO CLEAR

Tell the requester where to access the information. For example give them a link to where it is on the internet. If it is on Open Barnet (data portal) tell them the best search term to use or the data set name. If it is on barnet.gov.uk give them the

exact page link/s because the barnet.gov website search facility is dreadful.

Check that any links you provide still work!

Check that the information available actually is what they are asking for and answers the question. If someone asks for the TMO itself and you direct them to traffweb this will not be applying s21 as the whole TMO is not available on traffweb. If you are directing them to the spend data on the portal check that the information is actually on there and is findable. Do you need to give them a reference number or the exact vendor name?

Remember that you can use section 21 even if they will need to pay to access the information (eg land registry). You might want to say that in the response eg although you will need to pay a fee to access the property ownership from Land Registry, section 21 still applies as the information is accessible upon payment of a fee.

There has been case law that in some circumstances even a hefty fee (\pounds 1200) is reasonable and s21 can be applied. If you want to apply s21 and there is a fee in the \pounds 00s or \pounds 000s please check with IMT first, to avoid any IR.
