Thank you for your request received on 13 March 2021, for the following information:

**Under the Freedom of Information Act I would like to know when an occupant first registered to pay council tax for Flat 53 Croft House, Heritage Avenue, London NW9 5XY and Flat 39 Claremont House, Aerodrome Road, London NW9 5NW and the amount payable. I would also like to know the names of all people registered on the electoral register for these two properties since the properties were first built. This information would be recorded in the electoral registers which is open to public view.**

We have processed this request under the Freedom of Information Act 2000.

## **Response**

I can confirm that London Borough of Barnet holds some of the information you requested.

However, we consider that the following exemptions apply to some of the information requested. The remaining information is not withheld and is below.

***Under the Freedom of Information Act I would like to know when an occupant first registered to pay council tax for Flat 53 Croft House, Heritage Avenue, London NW9 5XY and Flat 39 Claremont House, Aerodrome Road, London NW9 5NW and the amount payable. I would also like to know the names of all people registered on the electoral register for these two properties since the properties were first built. This information would be recorded in the electoral registers which is open to public view.***

We consider that the absolute exemption set out in Section 40 (Personal information) subsection (2) applies to the information requested. Therefore, we have decided to withhold the information.

## **Refusal Notice Section 40(2)**

[Part 1 of Schedule 19](#) of the Data Protection Act 2018 amends the personal data exemption under section 40 of the Freedom of Information Act 2000 (FOI). These are consequential amendments designed to ensure that the correct provisions of the GDPR and the new Act are referenced instead of the now repealed DPA 1998. They

will not fundamentally impact when personal data can, and cannot, be disclosed in response to an FOI request.

Personal Information is governed by the Data Protection Act legislation and is defined as any information relating to an identified or identifiable natural person ('data subject'). It adds that: an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location number, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

The withheld information is exempt because disclosure would contravene the first data protection principle which requires that personal data is processed fairly and lawfully. Disclosure of the requested information would breach this principle and in particular the requirement of fairness.

I can confirm the following:

**Flat 53 Croft House, Heritage Avenue, London NW9 5XY:** Brought into the Council Tax list from 23 December 2011, the property is in Valuation Band C.

The charge for that financial year was £1,265.91.

**Flat 39 Claremont House, Aerodrome Road, London NW9 5NW:** Brought into the Council Tax list from 22 August 2013, the property is in Valuation Band C.

The charge for that financial year was £1,258.84.
