Our payment processing systems have changed and so we will only be accepting payments through BACS transfer. I would therefore kindly ask that each time you send a search request, please attach a confirmed BACS receipt along with the PDF copy of the plan.

Please send the PDF copy of the plan and the BACS receipt confirmation to [highways.searches@barnet.gov.uk](mailto:highways.searches@barnet.gov.uk). Please include the address of each search request on the subject title of the email.

Please note that as of the 1st of April 2021 the fee for each individual highway search request is £234.96. Please keep a note of the bank account details below for future search payments.
