Thank you for your request received on 21 March 2021, for the following information:

Who actually owns the 2 parcels of land mentioned in the title deeds, restrictive covenant regarding Amy Ellen Rebecca Hinge coloured yellow (University Car Park & Paddock). What exactly is the restrictive covenant as there's no exact details. Are they still active, presumably so as they have never been developed is it open space for the public and if so why is it fenced off.

We have processed this request under the Environmental Information Regulations 2004.

Response

The council holds the information requested and it is attached/ the answers to your questions are below

Who actually owns the 2 parcels of land mentioned in the title deeds, restrictive covenant regarding Amy Ellen Rebecca Hinge coloured yellow (University Car Park & Paddock). What exactly is the restrictive covenant as there's no exact details. Are they still active, presumably so as they have never been developed is it open space for the public and if so why is it fenced off.

We understand the land being enquired about was transferred to Middlesex University by the London Borough of Barnet on 14 th July 1995, pursuant to certain provisions of the Education Reform Act of 1988, having initially been sold to Middlesex Council in 1964 for the purpose of its functions under the Education Acts of 1944 to 1953.

Please find attached a copy of the transfer document, dated 14 th July 1995, together with the plan that was attached to that in the deed pack.

Also attached, for your information, is a copy of the conveyance between Amy Hinge and Middx County Council in 1964 and the plan attached to that which was in our deed pack.

Unfortunately our copies are not very clear, being only photocopies. However, these documents are a matter of public record and can be interrogated via the Land Registry web site.
