We have processed this request under the Environmental Information Regulations 2004.

### Response

I can confirm that London Borough of Barnet holds the information you requested.

However, we believe that the exceptions detailed below apply to the information you requested and so we are withholding that information. Please see the Refusal Notice below.

This is an information request relating to commercial property owned by your local authority.

Please provide the following information for 2020-21:

- \* What is the value of each commercial property held?
- \* What was the forecast yield for each commercial property held?
- \* What was the actual yield for the commercial property held?

I am writing to inform you that we have searched our records and the information you requested is not held by London Borough of Barnet.

We cannot give out the valuations of the Council's commercial assets for 202-2021 as they have not yet been audited, so they have not yet been confirmed.

We do not analyse the actual yields for each commercial property held, therefore we do not hold that information.

Until the asset valuations have been audited, we cannot release information about them.

We consider that regulation 12 (4) (d) (In course of completion, unfinished or incomplete) applies to the information requested because we consider that the request relates to material which is still in the course of completion, to unfinished documents or to incomplete data.

Therefore, we have decided to withhold the information. In applying this exemption, we have had to balance the public interest in withholding the information against the interest in favour of disclosure.

#### Factors in favour of disclosure

- The councils commitment to transparency
- Public interest in understanding that the council achieves value for money in it's contracts and expenditure

### Factors in favour of withholding

- The information is incomplete and is being prepared for publication
- The council publishes its accounts

In all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.
