Refusal Notice

Section 44 – Prohibitions on Disclosure

We consider that Section 44(1)(a) (Prohibitions on disclosure) provides an exemption from disclosure of information where the Public Authority holding it is prohibited by or under any other enactment ONS has legal obligations to protect the confidentiality of data it holds, under the <u>Statistics and Registration Service Act</u> <u>2007</u> and Death Certificates fall outside of the FOI Act, please contact the General Registrars Office for more information.

Section 44 is an absolute exemption and therefore the information will not be supplied to you.

Section 12 - Exceeds Appropriate Limit (Cost limit)

W e are refusing your request under section 12 because we estimate that compliance with your request will exceed the "appropriate limit" under section 12. The appropriate limit is £450 which is equivalent to 18 hours at £25 per hour. The per hour figure is set by Regulations rather than actual salary paid to any officers handling requests. The appropriate limit includes the time it will take the council to discover if it holds the information requested, to locate it, extract it and collate it as well as putting it into any particular format requested by the requester.

We have calculated that it will take approx 35 to comply with your request. Our calculation is as follows:

416 records @ 5 mins per case = 2,080 minutes, 34.5 hours @£25 /hr = £865.00

Therefore, we have decided to withhold the information.
