Thank you for your request received on 12 April 2021, for the following information:

#### I am writing in regards to the parking charge dispute (FOI) which took place on Mountfield Granville Road NW2 2 BA.

The parking restriction that was in place before the current restriction was located in Mountfield Granville Road NW2 2BA, near Mortimer Close.

The previous parking restriction stated that vehicles who are not resident permit holders can not park between the hours of 11am to Midday. Therefore I parked outside of the times 11am to midday, which I was wrongfully given a parking penalty for.

After a month a new parking restriction came into place at this same location.

I am now requesting the information for when the old parking restriction was changed and what the time restrictions for permit holders was on old Mountfield Granville Road NW2 2BA, near Mortimer Close parking restriction.

We have processed this request under the Freedom of Information Act 2000.

#### Response

The council holds the information requested and is answered below.

Granville Road, NW2, is situated in a Controlled Parking Zone (CPZ) that operates Monday to Friday 11am to 12 Midday.

There have been no changes to this CPZ.

However, please note that there are also lengths of single yellow line along Granville Road that operate at the following times below;

- Monday to Friday 8am to 6pm
- Monday to Friday 2pm to 3pm
