Thank you for your request received on 17 April 2021, for the following information:

I respectfully request copies of the following for the last 3 years;

1) A copy of all complaints regarding potholes on Tilling road on the roundabout entrance to Brent South Shopping Park.

2) A copy of all complaints regarding road damage on Tilling road on the roundabout entrance to Brent South Shopping Park.

3) A copy of all responses to complaints regarding potholes and/or road damage on Tilling road on the roundabout entrance to Brent South Shopping Park.

4) A copy of all and any repair work carried out on potholes and/or road damage on Tilling road on the roundabout entrance to Brent South Shopping Park.

5)A copy of all claims made against Borough of Barnet council regarding vehicle damage caused by potholes and/or road damage on Tilling road on the roundabout entrance to Brent South Shopping Park.

6) A copy of all complaints made regarding potholes and/or road damage on Tilling road on the roundabout entrance to Brent South Shopping Park and subsequently rejected, including reasons for rejection.

7) A copy of all complaints made regarding potholes and/or road damage on Tilling road on the roundabout entrance to Brent South Shopping Park and subsequently accepted, including reasons for acceptance.

We have processed this request under the Environmental Information Regulations 2004.

### Response

I can confirm that London Borough of Barnet holds the information you requested.

However, we consider that the following exceptions apply to some of the information requested - see refusal notice below. The remaining information is not withheld and is below.

We consider that regulation 13 (Personal information) applies to the information requested in questions 5 and 6.

Therefore, we have decided to withhold the information.

1) A copy of all complaints regarding potholes on Tilling road on the roundabout entrance to Brent South Shopping Park.

### **Refusal Notice**

Part 1 of Schedule 19 of the Data Protection Act 2018 amends the personal data exception Regulation 13 of the Environmental Information Regulations 2004. These are consequential amendments designed to ensure that the correct provisions of the GDPR and the new Act are referenced instead of the now repealed DPA 1998. They will not fundamentally impact when personal data can, and cannot, be disclosed in response to an EIR request.

We consider the information is subject to Regulation 13 because to release it would be a breach of the Data Protection Act 2018.

Personal Information is governed by the Data Protection legislation and is defined as any information relating to an identified or identifiable natural person ('data subject')". It adds that: an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location number, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

The withheld information is exempt because disclosure would contravene the first data protection principle which requires that personal data is processed fairly and lawfully. Disclosure of the requested information would breach this principle and in particular the requirement of fairness.
