I am sending this request under the Freedom of Information Act to ask for the information outlined below.

I would be very grateful if you could return your response to me by completing the attached xlsx document which contains the following questions:

Q1 Please confirm the total number of referrals your Multi-Agency Safeguarding Hub has received in the following financial years which involved an allegation of peer on peer sexual abuse among children under 18:

2017/18 2018/19 2019/20 2020/21

Q2 Please confirm the total number of referrals your Multi-Agency Safeguarding Hub has received in the following financial years which involved an allegation of peer on peer sexual abuse among children under 18 that occurred on any school or college premises:

2017/18 2018/19 2019/20 2020/21

Q3 Please confirm the total number of referrals your Multi-Agency Safeguarding Hub has received in the following financial years which involved an allegation of peer on peer sexual abuse among children aged 10 and under:

Q4 Please confirm the total number of referrals your Multi-Agency Safeguarding Hub has received in the following financial years which involved an allegation of peer on peer sexual abuse among children aged 10 and under that occurred on any school premises.

If you do not collect this data, please indicate or provide data for any years you have available.

We have processed this request under the Freedom of Information Act 2000.

Response

W e are refusing your request under section 12 because we estimate that compliance with your request will exceed the "appropriate limit" under section 12. The appropriate limit is £450 which is equivalent to 18 hours at £25 per hour. The per hour figure is set by Regulations rather than actual salary paid to any officers handling requests. The appropriate limit includes the time it will take the council to discover if it holds the information requested, to locate it, extract it and collate it as well as putting it into any particular format requested by the requester.

We have calculated that it will take approx 181 hours to comply with your request. Our calculation is as follows:

We are unable to provide this information within the statutory 18-hour limit because we do not collect this data in a retrievable format. To obtain this information we need to read each referral received by the MASH to ascertain if a referral was received regarding an allegation of peer on peer sexual abuse among children under 18.

Between the financial years 2017/18 to 2020/21 our MASH Team has received approximately 1086 contacts with Sexual Abuse as a presenting issue. It would take approximately 10 minutes to review each case to find out if a referral was received regarding an allegation of peer on peer sexual abuse among children under 18.

1086 cases x 10 minutes = 10860 minutes (181 Hours).

Advice and Assistance

Unfortunately, we cannot see a way of reducing the request scope to bring it in within 18 hours appropriate limit.
