Thank you for your request received on 10 May 2021, for the following information: Please could you provide me with the same information, but from January 2021 to the present day, or to the latest date the data is available.

(1) I would like to know how many adults (16+) in your council were referred to an Independent Domestic Violence Advisor (IDVA), or any other specialist domestic abuse service provider in your area, from January 2021 to the present day?

(2) I would like this information broken down by month, starting on January 2021 to the present day, or until the latest date you have this information available.

(3) For each month, please indicate how many adults were referred to an IDVA or another specialist domestic abuse service.

(4) For each adult please indicate which agency they were referred to, their gender, and the age of the person. Ideally, please provide the information in the following age categories: 18-30; 31-50; 51-65; 66-74; 75+.

We have processed this request under the Freedom of Information Act 2000.

Response

I am writing to inform you that we have searched our records and although we hold some of the information requested, some is not held by London Borough of Barnet because we do not collect this data in a retrievable format.

We have provided answers to your request below showing where we do not hold the information requested.
