Can you please confirm the number of planning applications received since 01/08/2020 for prior notification upward extension for houses and prior notification upward extension for flats. Further can you please confirm the number of applications approved under both categories since the same date .

We have processed this request under the Environmental Information Regulations 2004.

Response

I can confirm that London Borough of Barnet holds the information you requested. However, we consider that the following exceptions apply to some of the information requested.
