Clarification from Requestor: Is the financial statement and bank accounts separate for barnet homes and barnet homes repairs. Is there incoming or outgoings from one account to another. Who are the directors shareholder managers. For example when you received rent to barnet homes does any of the funds collected get used or go into the same account as barnet council. Is money transferred between the accounts. You said barnet homes is a separate company to barnet council I am asking for information on the records of and financial interaction between the two companies

The financial accounts for Barnet Homes and Barnet Homes Repairs are not separate - they share the same bank and financial accounts.

Barnet Homes Directors are as follows: Washington Ainabe, Aruna Bhatt, Eamon McGoldrick, Robert Webber and Tim Mulvenna.

Housing Revenue account rent from social dwellings is collected and paid directly into LB Barnet Bank Accounts.

Where money/rent may have been paid into an incorrect account (i.e into LB Barnet Bank Account) clear financial controls are in place to manage and authorise any transfer of payments.

Transactions between The Barnet Group and Barnet Homes is primarily through invoices, which are processed through the Accounts Payable System.

5 the details of barnet Council share any financial accounts with barnet homes.

Barnet Homes Ltd is a subsidiary of the Barnet Group which in turn is a 100% owned subsidiary of Barnet Council. The consolidated accounts of the Barnet Group are used to prepare the Council's group accounts. The statement of financial accounts
