London Borough of Barnet is currently signed up to Matrix SCM as our Neutral Vendor and the contract is in place until 31 October 2021. There is no extension currently agreed.

## All the Supplier Names who supplied yourself with temporary agency Labour in the above period.

We contract our agency usage via a Neutral Vendor, Matrix, and would not therefore be able to provide a breakdown of usage by supplier as this information is not held by Barnet council.

### The Actual spend value for each Supplier in the above period.

Total agency spend with Matrix SCM in the 12 months to April 2021 - £17.21m

### The types of roles That were supplied.

As a Local Authority London Borough of Barnet uses Matrix SCM to contract Social Care Staff, Waste Recycling and Street Cleansing Staff, Passenger Escort Staff, General Administration, Finance, Management and Project Staff to support the functions of the local authority - see attachment.
