Thank you for your request received on 3 June 2021, for the following information:

Under the freedom of information act, can you please provide me a list of all CPO's the local authority has made in respect of commercial properties during the period 1 April 2017 to date.

Please provide in excel format the date the CPO was made, the full address of the property, the name of the liable party responsible for payment of business rates at the time, the property reference number and the RV.

We have processed this request under the Freedom of Information Act 2000 and Environmental Information Regulations 2004.

Response

I can confirm that London Borough of Barnet holds the information you requested. However, we consider that the following exemptions and exceptions apply to some of the information requested.

Under the freedom of information act, can you please provide me a list of all CPO's the local authority has made in respect of commercial properties during the period 1 April 2017 to date.

Please provide in excel format the date the CPO was made, the full address of the property, the name of the liable party responsible for payment of business rates at the time, the property reference number and the RV.

The only CPO scheme identified as involving commercial properties is the Brent Cross Cricklewood CPO.
