1. How many applications for planning permission for residential properties were received/have been received for a) extensions, b) basements, c) loft conversions, d) conservatories and e) other in 2019, 2021 and 2021 to date. Please give data separately, broken down by calendar year.

If you do not hold the data broken down by the different types of home improvements as listed above, please provide the following:

2. How many applications for planning permission for residential properties were received/have been received in 2019, 2020 and 2021 to date. Please give data separately, broken down by calendar year.

We have processed this request under the Environmental Information Regulations 2004.

# Response

I can confirm that London Borough of Barnet holds the information you requested. However, we consider that the following exceptions apply to some of the information requested.

We consider that Regulation 6(1)(b) applies to the information requested because the information requested is already publicly available and easily accessible.

All planning data is already available online. You can search individually for this information on our website adding 'a) extensions, b) basements, c) loft conversions, d) conservatories' to the description keyword field under advanced search and selecting the date range you wish to search, details of permission granted or refused will be on each case record:

Unfortunately we cannot break down the information any further by searching for *a*) *extensions, b*) *basements, c*) *loft conversions, d*) *conservatories* as this search will

bring up any application with that wording. This will have to be searched on each individual application.

You are also able to search for Residential applications monthly and yearly on the advance search on the above link.
