# Section 40(2) - Personal data

We have witheld the names of the person(s) paying Council Tax by virtue of section 40 (2) and any discounts that apply under the Freedom of Information Act 2000 (FOIA), as disclosure of this information to the public generally, in the Council's view, would not be consistent with the data protection principle found in Article 5.1(a) of the General Data Protection Regulation (GDPR) lawfully, transparently and fairly.

We have considered whether disclosure is lawful and fair and whilst it may be lawful under Article 6.1(f) GDPR (legitimate interests) it would not be fair to the individuals concerned who would not reasonably expect the names of Council Tax payers to be disclosed or discounts applied as part of such a request.
