Thank you for your request received on 27 July 2021, for the following information:

**For the record, under a formal Freedom of Information request to LONDON BOROUGH OF BARNET COUNCIL, I require actual full profit and loss accounting in respect of all of the following:**

- \* All pension funds and ALL investments using the proceeds of Council Tax.**
- \* Enforcing tax liabilities and charges including court charges minus appeals and damages incurred.**
- \* Enforcing any and all policies of 'LONDON BOROUGH OF BARNET COUNCIL' upon the local community.**
- \* Enforcing evictions for non-payment of tax/arrears upon the local community.**

**You have a lawful and legal obligation, in your public office and in your private capacity to provide the evidence of material substance that there is a lawful obligation for I, the living man to be liable for Council Tax. I request that you also provide the material evidence of:**

- 1. The dictionary and Grammatical styles manual you are relying on in this matter;**
- 2. LONDON BOROUGH OF BARNET COUNCIL has proof that I is a person and liable to pay a non-domestic levy;**
- 3. LONDON BOROUGH OF BARNET COUNCIL has proof that it is mandatory for i, a living man, to be liable to pay CT;**
- 4. LONDON BOROUGH OF BARNET COUNCIL has proof that I is a registered corporation or resident of a dwelling;**
- 5. LONDON BOROUGH OF BARNET COUNCIL provides I with additional services outside of your statutory obligations;**
- 6. LONDON BOROUGH OF BARNET COUNCIL can make any demands whatsoever; against a determination that I is liable, for the non-payment of CT upon human-beings living here as inhabitants;**
- 7. LONDON BOROUGH OF BARNET COUNCIL has the lawful authority; to act over I a man without just-and-fair compensation;**
- 8. LONDON BOROUGH OF BARNET COUNCIL can force i to implicate i into 'aiding' and 'abetting' by funding acts of terrorism and/or illegal activities.**

We have processed this request under the Freedom of Information Act 2000.

## **Response**

The council holds the information requested and the answers to your questions are below.

The London Borough of Barnet strenuously denies your various accusations of fraud and crimes.

We would urge you to review the information contained in this Wikipedia page about the Freeman of the land movement where your concepts have originated from [https://en.wikipedia.org/wiki/Freeman\\_on\\_the\\_land](https://en.wikipedia.org/wiki/Freeman_on_the_land). Please pay particular attention to the example cases in England that are listed there. These arguments have been proven to fail on every occasion that they have been presented at Court. If you continue to withhold payment the Council will enforce payment and we would urge you to take professional independent advice before continuing with this approach.

***You have a lawful and legal obligation, in your public office and in your private capacity to provide the evidence of material substance that there is a lawful obligation for I, the living man to be liable for Council Tax. I request that you also provide the material evidence of:***

***1. The dictionary and Grammatical styles manual you are relying on in this matter;***

The London Borough of Barnet will primarily communicate in English.

***2. LONDON BOROUGH OF BARNET COUNCIL has proof that I is a person and liable to pay a non-domestic ic levy;***

The Local Government Finance Act 1992 and The Council Tax (Administration and Enforcement) regulations 1992.

***3. LONDON BOROUGH OF BARNET COUNCIL has proof that it is mandatory for i, a living man, to be liable to pay CT;***

The London Borough of Barnet is a public authority not a private corporation.

***4. LONDON BOROUGH OF BARNET COUNCIL has proof that I is a registered corporation or resident of a dwelling;***

If you are stating that you do not reside at this address it would be for you to provide evidence of this.

***5. LONDON BOROUGH OF BARNET COUNCIL provides I with additiona l services outside of your statutory obligations;***

Whilst Council Tax funds the Council's services it is not a payment for services received it is a tax.

***6. LONDON BOROUGH OF BARNET COUNCIL can make any demands whatsoever; against a determinat ion that I is liable, for the non-payment of CT upon human-beings living here as inhabitants;***

The Local Government Finance Act 1992 and The Council Tax (Administration and Enforcement) regulations 1992.

***7. LONDON BOROUGH OF BARNET COUNCIL has the lawful authority; to act over I a man without just-and-fai r compensation;***

The Local Government Finance Act 1992 and The Council Tax (Administration and Enforcement) regulations 1992.

***8. LONDON BOROUGH OF BARNET COUNCIL can force i to implicate i into 'aiding' and 'abetting' by funding acts of terrorism and/or illegal activities.***

Council Tax funds local services not illegal activities.
