S12 - cost limit (exceeds appropriate limit)

We are unable to provide this information within the statutory 18-hour limit because we do hold this data in a reportable format. To obtain this information we need to read each Looked after Child's file to ascertain if any of the children were the subject of Osman (threat to life) warnings, occasions children in care who have returned from a missing episode were found to have been exploited by county lines gangs, missing episodes where an individual child had been found to have been exploited by county lines gangs while missing

There are 479 LAC in our care. It would take at least 15 minutes to review each case to find out the information requested

479 cases x 15 minutes = 120 Hours.

We must therefore refuse your request, please see Refusal notice (Section 12) below.

Section 12 of FOIA states that the council does not have to comply with a request for information if the cost of compliance exceeds the appropriate limit of £450 calculated at £25 per hour with a limit of 18 hours. The appropriate limit relates strictly to the process of determining whether the information is held; locating, retrieving and extracting the information, or a document containing it.
