Thank you for your request received on 18 August 2021, for the following information:

2. Please state, out of the above figures, how many of those people were male and how many of those men had next of kin and how many of those men did not have next of kin?

3. Please state, out of the above figures, how many of those people were female and how many of those women had next of kin and how many of those women did not have next of kin?

4. Please state, out of the above figures, how many of those people were aged under 18, aged 18-59 or aged 60+

5. Please state, out of the above figures, how many of those people were cremated, how many were buried in a grave of their own and how many were buried in a shared or communal grave.

For clarity and comparative accuracy, I have included a table with headers which may help you interpret my questions above. I have also included columns for gender unknown just in case. I would be grateful, if possible, if you could provide the information in this way.

We have processed this request under the Freedom of Information Act 2000.

# **Refusal Notice**

#### S41 - Confidential information

Section 41 of the FOIA (Confidential Information) Section 41 of the FOIA states the following:

(i) Information is exempt information if:

a. It was received by the public authority from any other person (including another public authority) and

b. The disclosure of the information to the public (otherwise than in accordance with this Act) would constitute a breach of confidence actionable by that other person and

c. The duty to confirm or deny does not arise if, or to the extent that, the confirmation or denial that would have to be given to comply with section 1(1) (a) would (apart from this Act) constitute an actionable breach of confidence.

Section 41 (FOI) provides an absolute exemption for information meeting this definition. Whilst records relating to deceased people do not carry a common law duty of confidentiality, it is Council policy that records relating to deceased people should be treated with the same level of confidentiality as those relating to living people. Access to the health records of a deceased person is governed by the Access to Health Records Act 1990
