 - 2020-2021 = £9,256.40
 - 2019- 2020 = £5757
 - 2018-2019 = £1215
- 2. What is your annual budget each year within the Information Governance team for staff development/training?

The budget is held centrally for the whole directorate and is not team specific.

The Records and Information Management Team sit within the Assurance directorate and this directorate has a total training budget of £26,000 for 2021/2022.
