£511,926 of which £359, 738 was staff cost and £152,188 other costs. Building costs are not included as not charged to individual departments.

(b) What in that year 2018/19 was the total income (including statutory fees and payments for additional services provided) generated by the Council's registration service? How much of this total was made up by statutory fees? How much, in as much detail as can be provided, came from each of the other principal sources (e.g., enhanced wedding ceremonies, naming ceremonies etc)?

Total income was £623,988 of which £351,696 was from non-statutory services e.g. weddings, citizenship ceremonies, EPRS.
