R12(4)(b) – Manifestly unreasonable

We consider that regulation 12(4)(b) (Manifestly unreasonable) applies to the information requested for question 2 because we consider that the request is manifestly unreasonable.

This is because it will take up too much council resource and is disproportionate effort for the benefits given, the information that you have requested would mean locating and retrieving each planning file listed above and would take 10 minutes to look at each individual file, a total of over 20 hours will then be spent on retrieving correspondence from each file.

Therefore, we have decided to withhold the information.

In applying this exception, we have had to balance the public interest in withholding the information against the interest in favour of disclosure.
