The council holds the information requested and it is attached/ the answers to your questions are below

Yes the Council is a Lead Local Flood Authority. There is a dedicated Flood Risk Officer in the Council and there are few outsourced resources- 1 resource for Highways drainage and 2 full time resources (on average) for planning consultations.
