The council holds the information requested and the answers to your questions are below.

## Dear Sir/Madam,

For a study purpose, I would like to ask the information in your borough under the Freedom of Information Act 2000.

# Can you please provide the details for the years from 2017 to 2021? Please also say whether it is in residential roads, main roads, town centres or Strategic route networks.

Data is mainly held in terms of the (April-March) financial year in which the facility was provided, so is identified in that way below. The main source are reports related to provision made via particular transport funding streams, although other provision has been included where identified. Some roads in Barnet (A1, A41 & A406) are controlled by TfL or are motorway (M1) controlled by Highways England and responses do not include any provision that might have been made on these roads, and does not include provision that might have been made by developers.

## 1. How many new cycle lanes were installed?

A number of cycle lanes is not particularly meaningful, but see information below. This includes off road routes as well as on road lanes.

2016/17 2 [1.14km off-road route widened and improved. 160m route provided on car-park verge]

2017/18 0 [Completion of items above and start of items below]

2018/19 1 [880m off-road route widened and improved].

Introduction of experimental route below involved widening and upgrading some short lengths of pre-existing advisory lane.

# 3. How many pop-up cycle lanes were installed?

One experimental cycle route installed 2020/21. Approx 3 km on-road on main road including town centre sections. Route incorporates approx 2.2km of cycle lane and 1 km of bus and cycle lane, plus stretches without separate lanes.

Some adjustments/improvements made to that route in 2021/22.

# 4. How many miles/kilometres of cycle lanes were improved?

None identified except as set out in responses to Q1, 2 & 3 above.
