This request relates to the double yellow lines installed on Friern Barnet Lane N20 in March 2022 in the immediate vicinity of Friern Court N20 ONJ.

1. what consultations were carried out with A) local residents and B) others prior to the making of decision to install the yellow lines. Please provide copies of the documents authorising such consultations and any reporting on the responses;

There is a legal agreement (s.278 Highways Act) in place between the Council and the Developer of Friern Court to carry out off-site highway works attached to the Development. The s.278 legal agreement includes proposed waiting restrictions subject to statutory consultations. The proposals to introduce waiting restrictions (yellow lines) were prematurely implemented by the Developer's contractor ahead of statutory consultation. Arrangements have been made to take up the newly laid waiting restrictions and await for the necessary consultations to take place.
