I can confirm that London Borough of Barnet holds the information you requested.

From January 2021 we paused the processing of memorial park bench applications, whilst we updated our processes. We have supplied the most up to date and current documents that we have used since January 2021.

During 2020 applications were dealt with on a case by case basis, there are no specific internal documents for each of the 7 applicants.

2: Any internal documents relating to the funding allocation for memorial park benches within the borough, for the last two years.

If it is not possible to provide the information requested due to the information exceeding the cost of compliance limits identified in Section 12, please provide advice and assistance, under the Section 16 obligations of the Act, as to how I can refine my request.

We do not hold any internal documents relating to the funding allocation for memorial park benches, as there is no funding allocation. Customers are charged the full costs of supplying and installing the memorial benches, as set out in the attached document 'Memorial bench costings April 2022".

Refusal Notice

Please note that some redactions have been applied to third party personal data as per R13 - Personal data. R13 - Personal data Part 1 of Schedule 19 of the Data Protection Act 2018 amends the personal data exception Regulation 13 of the Environmental Information Regulations 2004. These are consequential amendments designed to ensure that the correct provisions of the GDPR and the new Act are referenced instead of the now repealed DPA 1998. They will not fundamentally impact when personal data can, and cannot, be disclosed in response to an EIR request. We consider the information is subject to Regulation 13 because to release it would be a breach of the Data Protection Act 2018. Personal Information is governed by the Data Protection legislation and is defined as any information relating to an identified or identifiable natural person ('data subject')'. It adds that: an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location number, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person. The withheld information is exempt because disclosure would contravene the first data protection principle which requires that personal data is processed fairly and lawfully. Disclosure of the requested information would breach this principle and in particular the requirement of fairness as it could allow individuals to be identified.
