Refusal Notice S43 - Commercial interests

We consider that the qualified exemption set out in Section 43 (Prejudicial to commercial interests) subsection 2 applies to the information requested. Therefore, we have decided to withhold the information.

Section 43 (2) of the Act provides a qualified exemption from disclosure if such disclosure would prejudice the commercial interests of any person. The documentation between our fund managers and London Borough of Barnet is commercially sensitive and confidential and we have consulted with and considered both parties' interests. These interests are commercial in nature as they relate to commercial dealings and are not merely financial.

The various reports provided by our fund managers contain a range of commercially sensitive information and intellectual property which, if released into the public domain, would result in damage to their firm, and potentially also to other third parties (London CIV and the managers of their sub-funds) as well as to London Borough of Barnet.

This information includes:

- Fees and details of other commercial terms;
- Key contractual details and terms such as asset allocation ranges, limits of liability and indemnities;
- Key decision-making and investment selection criteria; and
- The fund manager's and other parties' intellectual property including rating and selection methodologies, modelling assumptions, and details of services.

This is a qualified exemption and the public interest test applies.

In applying this exemption, we have had to balance the public interest in withholding the information against the interest in favour of disclosure.

Factors in favour of disclosure

- Furthering the understanding and participation in the public debate of issues
- Facilitate the accountability and transparency of public authorities for decisions taken
- Facilitate accountability and transparency in the spending of public money
- Allowing individuals to understand decisions made by public authorities affecting their lives and, in some cases, assist individuals in challenging those decisions

Factors in favour of withholding

- Adverse impact on Council and its contractors/ partners due to detail on commercial terms
- Council and contractors position in a competitive environment, market sensitivity of information and potential usefulness to competitors
- Prejudice caused to the Council's bargaining position for the future as commercial organisations may become reluctant to enter into further free and frank negotiations which would undermine the Council's ability to fulfil its role effectively and prevent it from achieving the value for money that is so important
- Negative effect on competitiveness if competitors were to have access to information
- Need to obtain value for money

In all the circumstances of the case, we consider the public interest in maintaining the exemption

outweighs the public interest in disclosing the information and so the information is withheld.
