Response

I am writing to inform you that we have searched our records and although we hold some of the information requested, some of the information you requested is not held by London Borough of Barnet.

We have provided answers to your request below.

Under the Freedom of Information Act, can you please let me know the following? Please don't send links to council reports - I am only after the below information.

1) What was you annual net spend on public sports and leisure facilities and pitches for the 2012/13 financial year, compared to the 2021/22 financial year please?

The Council's 5 leisure facilities are operated by a third party partner, Better are responsible for operation and maintenance of the facilities, however the Council maintain liability for the roof and structure with a reactive maintenance net spend of c,£21,500 in 2021/2022. Due to the migration of the Councils finance system in 2014, we are unable to provide financial data for the 2012/2013 financial year.

2) How many school playing fields were there in May 2012 compared to May 2022?



The Council does not hold this data. The requestor will need to contact schools individually to obtain this information.

3) How many free-to-use public sports fields were there in May 2012 compared to May 2022?
