We have processed this request under the Environmental Information Regulations 2004.

Response

I can confirm that London Borough of Barnet holds the information you requested.

However, we believe that the exceptions detailed below apply to all of this information and this is withheld. Please see the Refusal Notice below.

Refusal Notice

R13 – Personal data

We have withheld copies of the objection letter(s) received by virtue of Regulation 13 of the Environmental Information regulations 2004, as disclosure of this information to the public generally, in the Council's view, would not be consistent with the data protection principle found in Article 5.1(a) of the General Data Protection Regulation (GDPR) lawfully, transparently and fairly. We have considered whether disclosure of objection letters is lawful and fair and whilst it may be lawful under Article 6.1(f) GDPR (legitimate interests) it would not be fair to the individuals concerned who would not expect their written comments to the Council's consultation on the crossover to be released.

We consider that regulation 13 (Personal information) applies to the information requested.

Therefore, we have decided to withhold the information.



R12 (4)(d) - Material which is still in the course of completion, to unfinished documents or to incomplete data

In addition, the crossover application is an unfinished process. Release of details of any objection(s) received before a decision on the crossover application is made could give a misleading and inaccurate picture.

In relation to the public interest test, these factors are that the decision making processes of public functions should be transparent and open to scrutiny in order to inform the public debate. The EIRs are in place to ensure public access to environmental information and releasing information. The process of the crossover application hasn't been completed yet, and we cannot provide a response until the applicant has been advised of the outcome. In providing this information ahead of the Council's formal decision would present a risk of misinformation with no clear advantage to the public interest.

Further Advice and Assistance. I can advise that once a decision has been made and the applicant informed we will be able to give you a high level summary of the nature of the objections received and we will be in a position release this to you.
