I can confirm that London Borough of Barnet holds the information you requested.

For all sites May I kindly request :

What months are bonfires allowed? By LBB.

Each allotment operates under a lease between the society and the council and each lease may be slightly different. Although all leases are based on a template, the East Finchley Lease says the following in respect of bonfires; 'Not permit any fires or bonfires to be lit on the Property except (i) bonfires (for the purpose of burning vegetation and like matter) by allotment holders on their respective allotment plots on no more than one specified day of each month during the months May to September (days to be specified and advertised by the Tenant) and at any time on any day during the months October to April (ii) bonfires by the Tenant for communal purposes at an appropriate location under the supervision of a proper and responsible designated person on no more than one occasion each month during the months May to September days to be specified by the Tenant and at any time on any day during the months of October to April'.

Are there any day or time or month restrictions?

Please see above.

Informal - 1 Verbal warning.

How many residential complaints made in last 5 years to LBB re bonfires for each of these allotment sites and when? I am specifically interested in the East Finchley allotments at Plane tree walk n2 and Fuel lands - and others in Finchley / Barnet and using info of the other sites for comparison. Please provide stats for all.

Complaints have been made regarding bonfires at the following allotments:

- Coppets Road/Halliwick Allotments
- Hendon Grove allotments x2.
- Deans Lane Allotments
- Colindale Allotment

There have been no relevant complaints have been made regarding burning at the Fuel Lands or East Finchley Allotments.

Have there been any complaints made to LBB for any BBQs or other fires made on residential properties in the following Roads and areas: Creighton Ave Other local county roads in N2 Any in N2 Any in Barnet? What are the restrictions for residential fires? Times etc? 21 complaints have been made to Barnet within the last 5 years regarding residential burning and/or smoke emissions. None of these were in the N2 area. BBQs are not included in this number, as cooking odours/emissions from residential properties are not considered to be a nuisance under the legislation, and therefore cannot be enforced on.

Complaints were received in January 2022 regarding large scale burning close to Martin School and Creighton Avenue; it was initially assumed that either Fuel Lands Allotments or East Finchley Allotments were the culprits, however, as the investigation progressed this was found not to be the case. The Islington and St Pancras Cemetery were the culprits in this situation, and were dealt with accordingly.

Regarding residential restrictions on burning/fires; the Smoke Control Regulations and the Clean Air Act 1993 provide and define the restrictions. Restrictions are typically placed on the fuel and the device(s) used for burning. Further information is available at the following websites:

Has the environmental office carried out any inspections in any of the above allotments re bonfires/ fires?

There has been one visit to Hendon Grove Allotments.

Has the environmental health office issued any warnings formal or informal on any of these sites?

An informal warning was issued to the management of the Hendon Grove Allotments.

May I have a copy of any warnings?

Barnet's policy is not to provide documents with potential legal implications to third parties. Please see the Section 44 notice below.

How many warnings have been given to EF allotments?

Two informal warnings were given, however, these allotments were not the cause of the issue, as explained above.

How many warnings can be given before action taken?

One, however this is assessed on a case by case basis and depends on the frequency of the disturbance, and whether a nuisance has been witnessed. One per investigation is a typical frequency.

How many incidents in all allotments where fire brigade called out?

Environmental Health do not have access to fire brigade data.

All info - In last 5 years.

Are there any air pollution tests done around Martin school area? May you let me know figures?

Yes; Pollution outside of Martin School is monitored as part of the evidence gathering process for the A1000 cycle lane. This data will be available online when the Air Quality Annual Status Report for Barnet (May 2022) is published. The report is currently being reviewed by DEFRA. Are bonfires allowed on allotments?

Yes, bonfires and burning of garden waste is not illegal, however we do discourage it in Barnet.

Do you plan to prevent or restrict bonfires on allotments in future?

We have tried in past and are not opposed to trying again. However, the last time this was attempted, the proposal was heavily opposed at public consultation, which resulted in the proposal not going ahead. Public consultation will be required if we were to propose this again.

Has LBB ever written to East Finchley allotments about bonfires?

Yes, as above.

May I have copies?

Barnet's policy is not to provide documents with potential legal implications to third parties.

Has LBB provided skips free or paid for to EF allotments in Plane tree walk?

LBB have not supplied a skip service to the above allotment site.

Subs 2) allows a NCND. Usually where to confirm or deny if we hold info would itself be a breach of law/a court order.

Worked example - S44 – Prohibitions on Disclosure

We consider that Section 44(1)(a) (Prohibitions on disclosure) provides an exemption from disclosure of information where the Public Authority holding it is prohibited by or under any other enactment, in this instance Public Contract Regulations.

Section 44 is an absolute exemption and therefore the information will not be supplied to you.
