We do not commission any specialist provision for Young People leaving prison/custody. The leaving care team support YP to access their priority entitlements to housing, on-release from custody this would most likely be temporary accommodation. Barnet Homes will be able to advise if they use specialist providers for people returning to the community from custody. Specialist accommodation for people returning to the community is primarily Approved Premises – this is managed by probation.
