The list provided below is what is held on our database, but we cannot be definite that all of these businesses are still trading in shisha. Shisha bars change hands frequently and some drop in and out of the shisha trade depending on customer levels.

# 3. If there are premises which are operating that do not comply with the Smoke Free Regulations, please provide a justification as to why they are permitted to continue operating.

The compliance data is only based on our latest visit which may have been some years ago.

Where compliance is unknown this signifies that there was no shisha being offered at the time of the inspection, also several places had to close during Covid lockdown or cease offering shisha, we don't know if they all resumed shisha provision.

Where premises are non-compliant have been advised of what needs to change and have been warned in writing. During Covid lockdown the Environmental Health team was on other duties and since lockdown we have been obliged to focus on catching up with high priority food safety inspections and related work. We hope to resume our shisha non-compliance interventions when we are back on track with our other government led priorities. Formal smoke free enforcement is extremely resource intensive and unfortunately we do not have such resources available at this time.
