The scheme has been in operation for over 18 months.

Please give me figures for the number of cyclists using the road, separately for going north and south, by month since the start of the scheme to current. The purpose is to judge whether the scheme has resulted in more use by cyclists.

Monthly figures are needed to ignore the months of Covid, which would not be represented.

This has been asked for previously, but no statistic were given at that stage.

We have processed this request under the Freedom of Information Act 2000.

### Response

The council holds the information requested and the answers to your questions are below

#### Cycle Lane East Finchley Station

The scheme has been in operation for over 18 months.

Please give me figures for the number of cyclists using the road, separately for going north and south, by month since the start of the scheme to current. The purpose is to judge whether the scheme has resulted in more use by cyclists.

Monthly figures are needed to ignore the months of Covid, which would not be represented.

This has been asked for previously, but no statistic were given at that stage.

Traffic volume, including cycle count surveys, been carried out periodically along the route. As alluded to in the question, these figures may have been impacted by Covid. Now that we are in a post covid environment, further traffic volume surveys are planned, commencing in September until the end of the year.

We consider that regulation 12(4)(d) (in course of completion, unfinished or incomplete) applies to the information requested here, because we consider that the request relates to material which is still in the course of completion, to unfinished documents or to incomplete data. Therefore, we have decided to withhold the information. For further information relating to this exemption, please refer to the final paragraph of our response.



In applying exemptions, we have had to balance the public interest in withholding the information against the interest in favour of disclosure.

#### Public interest test considerations

I have considered whether the public interest in maintaining the exception outweighs the public interest in disclosing the information. There are a number of public interest arguments that weigh in favour of disclosing the information you have sought:

- The general principal of maximising openness and transparency that the EIR and the Council aspire to;
- The benefits of ensuring transparent and accountable government by disclosing how the Council makes decisions and receives and spends public money;

However, there are also public interest arguments against disclosure:

- Releasing the information as currently held would almost certainly provide an inaccurate picture of the data, as the process of data collection has not yet finished.
- The decision making process that the data relates to is ongoing, and releasing
  it at this time would have a negative impact on procedural integrity,
  specifically due to the fact that the data as it stands is incomplete and
  therefore misleading

We find that in all circumstances of the case, the public interest in withholding outweighs the public interest in disclosing at this current time.
