We have processed this request under the Environmental Information Regulations 2004.

## **Response**

I can confirm that London Borough of Barnet holds the information you requested.

However, we believe that the exceptions detailed below apply to some of this information and this is withheld. Please see the Refusal Notice below.

Please find attached CPZ implementation resident letter dated 16 June 2022 which sets out the rationale for the experimental CPZ.

Residents, local businesses and other interested parties may submit their support or objection to an experimental CPZ at any time within the consultation period which ends on **25th January 2023**.

An experimental CPZ may be introduced for up to 18 months and while it is in force any changes are monitored and assessed (and further changes made if necessary). The number of replies and nature of replies is withheld as this is a live and ongoing consultation exercise.

## **Refusal Notice**

**R12(4)(d) - Material which is still in the course of completion, unfinished documents or incomplete data**

We consider that regulation 12(4)(d) - Material which is still in the course of completion, unfinished documents or incomplete data applies to the information

requested because we consider that the request involves information that is incomplete.

Therefore, we have decided to withhold the information for the reasons set out below.

R12 (4)(d) Material which is still in the course of completion, to unfinished documents or to incomplete data In the case of the draft, the documents are an unfinished, unofficial and raw form which does not fully represent the originating authority's views. Release could give a misleading and inaccurate picture. These factors are that the decision making processes of public functions should be transparent and open to scrutiny in order to inform the public debate. The EIRs are in place to ensure public access to environmental information and releasing this early numbers and details of consultation responses would present a risk of misinformation with no clear advantage to the public interest. We will meet out transparency and scrutiny objectives by deciding whether to make the experimental CPZ permanent or update with changes in the light of all the consultation responses received.
