- 1. & 2. Attached provides information on surveys undertaken from April 2019 to date in the former Woodhouse and Coppetts wards and current Woodhouse and Friern Barnet wards (depending on the date of the survey).

Surveys involving a loop across the road captures speed, volume and a level of classification of vehicles. Radar or camera surveys are alternative ways to capture some of this type of information, and counts of turning vehicles and particular classes of vehicle/road user often make use of cameras to provide a manual classification. Details on the attached include any of these.

They relate to surveys commissioned by the Highways Service. Other organisations may also commission traffic studies, notably to support planning applications etc. but are not included here. (Studies related to specific planning applications can be viewed via the planning pages on the council website if desired).

3. Please provide a similar list of proposed future traffic studies within Woodhouse and Friern Barnet Wards.

In our current year work programme plans are being made for surveys in Woodhouse Ward and Friern Barnet Wards for two schemes identified from issues in School Travel Plans:

 Surveys at A1000 High Road junction with Squires Lane are planned to capture pedestrian and vehicle turning movements at the junction to consider and address issues raised through the School Travel Plan for Our Lady of Lourdes School. • Speed (and potentially other) traffic surveys are planned for the area surrounding Hollickwood School (details still being confirmed).

Other studies and scheme proposals may emerge from requests received. Scheme proposals for next financial year are not yet agreed and programmed and details of survey locations and requirements for these will not be determined until then.
