## **Response**

The council holds the information requested and the answers to your questions are below.

***Please can you tell me***

***\* The number of secure residential cycle spaces that were installed in the borough prior to 4 May 2022. Please break this down according to spaces in on-street cycle hangars or any other cycle storage solution (such as those on estates).***

2 on-road cycle hangars (12 spaces) on the Barnet highway and 23 hangars (138 spaces) at Barnet Home's locations.

***\* The number of secure residential cycle spaces installed in the borough at the time of this request. Please break this down according to spaces in on-street cycle hangars or any other cycle storage solution (such as those on estates).***

12 spaces on-road and 156 spaces at Barnet Homes sites. An additional 3 bike hangars were installed at 2 Barnet Homes sites in August 2022.

***\* The number of new secure residential cycle spaces that are planned to be installed prior to 7 May 2026. Please break this down according to spaces in on-street cycle hangars or any other cycle storage solution (such as those on estates).***

5 bike hangars are planned to be installed by March 2024 if approvals are granted. Funding beyond this has not been announced.

£72 per space in an on-road bike hangar. Spaces within the Barnet Homes bike hangars are free.

For the 2 existing hangars on-road, 27 residents are on a waiting list for a space in the hangar on Somerton Road, NW2, and no-one is waiting for a space within the hangar on Grahame Park Way, NW9. The Council has 136 private resident requests for spaces within potential on-road bikehangars across 80 locations in Barnet.

Cyclehoop Ltd maintains and operates the 2 on-road bike hangars. Barnet Homes maintains and operates the hangars on their sites.
