## **Response**

The council holds the information requested and the answers to your questions are below and attached.

***May I have an update on the current status the Barnet Cycleway (<https://engage.barnet.gov.uk/Cycleway>) and information of LB Barnet's LIP allocation following TfL's recent £80m funding settlement with central government.***

### ***Is the Barnet Cycleway funded?***

The Barnet Cycleway (Barnet section of a proposed quiet cycle route between Hornsey and North Finchley) is not currently funded.

### ***- When does LB Barnet aim to deliver the Barnet Cycleway?***

There is no date set for delivery of this proposal at the moment. Officers are planning to develop a more detailed approach to determine the priority and delivery programme for cycling proposals across the borough as part of a refresh of the Council's Long Term Transport Strategy. This work is just commencing, and the cycleway proposal will be considered as part of this.

**- What cycle schemes will LB Barnet spend its LIP allocation on, following TfL's recent £80m funding settlement with central government?**

The £80m 2022/23 headline figure in the settlement between TfL and DfT addresses TfL delivery – chiefly on their own roads. However, London-wide there is £69M for borough funding that includes the LIP allocation and dedicated programmes including some related to cycling. Current year (2022/23) and future year proposals (23/24 & 24/25) will be published here [Agenda for Environment and Climate Change Committee on Wednesday 25th January, 2023, 7.00 pm \(moderngov.co.uk\)](https://barnet.moderngov.co.uk/ieListDocuments.aspx?CId=695&MId=11144&Ver=4) (<https://barnet.moderngov.co.uk/ieListDocuments.aspx?CId=695&MId=11144&Ver=4>) shortly as an appendix to a committee report.

Those proposals for 2022/23 and 2023/24-2024/25 specifically related to cycling are attached, titled Barnet Cycleway, in brief. \* Indicates funding wholly or in part from a dedicated programme.
