1. What is your annual budget for individuals accessing Tier 4 residential treatment for substance use in the financial years 2021/22 and 2022/23

In Q4 2020/21 and the whole of 2021/22, we received £69,173.60 Tier 4 funding from the Rough Sleeping Drug and Alcohol Treatment Grant, £11,894.20 for inpatient detox and £57,279.40 for residential rehab. The funds which were not used during the year were rolled over into 2022/23, when the combined budget for detox and rehab was £45,942.

2. How much of this budget has been spent on individuals accessing Tier 4 residential treatment centres: a) how much has been spent on detox b) how much has been spent on residential rehabilitation (re 2022/23 please provide actuals for year to date and projection for Quarter 4)

In 2021/22, the RSDATG spend on Tier 4 was £8,421.43 for detox and £17,742.15 for rehab. In Q1-3 2022/23, the RSDATG spend on Tier 4 has been £42,892.86 (combined budget, most provision from centres which offer detox and rehab together).

*NOTE: We are not able to provide the breakdown of detox and rehab as this is all contained within one budget.

53 service users were agreed for Tier 4 funding and completed their detox/rehab treatment.

Detox and Rehab (including Detox + and standalone Rehab) - 29

5 service users were funded through RSDATG in 2021-22 and 2022-23 to date, who were assessed as either at risk of rough sleeping or currently rough sleeping.

5. How many individuals successfully completed residential treatment placements, and how many did not complete their planned treatment.

46 service users were agreed for Tier 4 funding and completed their detox/rehab treatment.

7 service users were agreed for Tier 4 funding but did not complete their detox/rehab treatment.

6. What is the projected treatment budget for the financial year 2023/24

The main contract funding for Tier 4 will be the same as 2022/23.

The grant amounts for RSDATG and SSMTRG in 2023/24 have not yet been confirmed.
