It has not been possible to identify the number of reports of unlicensed HMOs we have received from the record because of the generic coding used for complaints in connections with HMOs, both licensed and unlicensed.

Q2 How many fines has the council given out to landlords for failing to have a HMO license over the last five years? And what is the total value of these fines? Can I get an annual breakdown please.
