Thank you for your request received on 25 January 2023, for the following information:

I would be most grateful if you could provide the following information in respect of providers of exempt accommodation (regardless of whether they are registered as providers of social housing with the RSH) covering the period of the last 3 financial years (i.e. 2019-20, 2020-21, 2021-22):

1. details of the lowest awarded eligible core rent;

2. details of the highest awarded eligible core rent;

3. details of the lowest awarded gross eligible rent (i.e. inclusive of the core rent and the eligible service charges);

4. details of the highest awarded gross eligible rent (i.e. inclusive of the core rent and the eligible service charges); and

5. details of any core rents and gross eligible rents where the claimed amount is higher than the highest awarded amounts AND has been subject to an appeal to the first-tier tribunal social entitlement chamber.

We have processed this request under the Freedom of Information Act 2000.

# Response

I can confirm that the council holds some of the information you requested. However we are withholding some of the information because we consider that an exemption applies to it.

Further details of where this exemption applies are given below.

## Refusal Notice S12 – Exceeds Appropriate Limit (cost limit)

We are refusing parts 1 & 2 of your request under section 12 because we estimate that compliance with your request will exceed the "appropriate limit" under section 12. The appropriate limit is £450 which is equivalent to 18 hours at £25 per hour. The per hour figure is set by Regulation rather than actual salary paid to any officers handling requests. The appropriate limit includes the time it will take the council to discover if it holds the information requested, to locate it, extract it and collate it as well as putting it into any particular format requested by the requester.

We have calculated that it will take approximately 1571 hours to comply with your request.

Our calculation is as follows: Eligible service charges are imbedded in the gross rent figures and are not otherwise specified in the SHBE reporting. To obtain information on core rents, we'd need to manually check claims listed on 36 SHBE returns. It is estimated it would take 5 minutes to access each claim and cross check the rent breakdown. The were 524 supported / exempt accommodation cases at the end of 21/22: 524 x 5 / 60 = 43.66 hours per SHBE return, x 36 months = 1571 hours.

# Advice and Assistance

As our reporting tools do not separate core rent and eligible service charges, manual checking of claims is necessary to provide the information requested under part 1 & 2. Unfortunately due to the volume of exempt / supported claims we have on a monthly basis, we are unable to comply with your request for our minimum reporting period (1 month). Instead, we could provide a random sample of cases, and list core rents and eligible services.
