The number of street parties is unpredictable, but we would expect there to be upwards of 100, and therefore costs to be incurred in the regions of £80k.

In addition, we will be contributing some funding towards an all-day public festival event in Golders Hill Park. While the majority of the costs for this will be borne by the City of London Corporation, Barnet will contribute £17k.

We also intend to make £10k available in small grants of £500-£1000 for community groups to hold their own events. This is for events in public spaces or buildings and does not include street parties.

Our total budget for the Coronation is therefore approximately: £107,000

The costs Highways incurred for the street parties relating to the Queen's Jubilee event was circa £83,000 for 130 applications. This included officer time to process the applications, contractor costs for the measures on the ground and the Traffic Management Order costs.
