Within the development boundary

Attached are the approved Pedestrian and Cycle Strategies for Phase 1 (South), Phase 2 (South) and Phase 5A. Condition 2.8(a) of the outline planning permission for Brent Cross Cricklewood requires the developer to submit the strategy setting out the pedestrian and cycle routes within a given phase or sub-phase of the

development. The Local Planning Authority consult Transport for London on each strategy and therefore these documents are approved by TfL as a result.

Phase 1 (South)

Barnet Planning reference 18/6296/CON

Submission of details pursuant to Condition 2.8(a) (Pedestrian and Cycle Strategy) relating to Phase 1 South (comprising Phase 1A South, Phase 1B South and Phase 1C) of planning permission F/04687/13 dated 23/07/14.

Phase 2 (South)

Barnet Planning reference 20/4805/CON

Submission of details pursuant to Condition 2.8(a) (Pedestrian and Cycle Strategy) for the Phase 2 (South) (Plots), Phase 2 (South) (School), Phase 2 (South) (Thameslink Station Approach) and Phase 2 (South) (Thameslink Station Eastern Entrance) sub-phases of planning permission F/04687/13 dated 23/07/14 for the comprehensive development of Brent Cross Cricklewood regeneration area.

Phase 5A

Barnet Planning reference 22/2841/CON

Submission of details pursuant to Condition 2.8(a) (Pedestrian and Cycle Strategy) for the Phase 5A sub-phase of planning permission F/04687/13 dated 23/07/14 for the comprehensive development of Brent Cross Cricklewood.

Outside of the development boundary

As part of the outline planning permission, the developers were to submit an Area Wide Walking and Cycling Study (AWWCS) to show where the internal pedestrian and cycle routes will meet with those external to the site and to highlight the key corridors that require improvements, etc.

The Area Wide Walking and Cycling Study (AWWCS) (document reference No. 47065005-TP-RPT-036 Rev 03, dated 27th November 2014) was submitted pursuant to Condition 1.20 of the outline planning permission for the comprehensive redevelopment of the Brent Cross Cricklewood Regeneration Area and approved under application reference 14/08105/CON in September 2015 (see attached). An addendum to the AWWCS document was submitted in July 2015 (see attached) and also approved under the same application (reference 14/08105/CON) (also attached).

As a result of a number of alternative proposals for specific aspects of the approved infrastructure within Phase 1A North, and discussions between Barnet and Transport for London (TfL), a further addendum to the AWWCS was submitted in December 2015 and approved in 2016. The addendum details where the alternative proposals

would result in an amendment to the approved Area Wide Walking and Cycling Study.
